First, Past District Governor Joe Ruskey of the Prairie du Chien Club has worked tirelessly on behalf of the District and Rotary for many years. Joe has been awarded the Service Above Self Award by Rotary International. This year this award went to only 143 of the over 1 million Rotarians in World. Congrats Joe!

Second, Ivan Haynes of the Madison East Monona Rotary Clubs passed away in 2018 at the age of 87. This past January our District received word that, through cumulative giving of over a quarter of a million dollars, Ivan was inducted into the Rotary Foundation's prestigious Arch Klumph Trustee's Circle. His gifts will continue to benefit our District and Rotary for many years to come.

District Membership Team Initiatives:

- We have launched the *Membership Growth Grant* with the purpose of empowering clubs to strengthen their membership through creative membership initiatives.
- We have a District Membership Team of 6 including 4 region membership masters providing closer support to clubs.
- o Membership Leads -We have received 33 leads from RI, 8 have become members, 20 are still in process, 5 are no longer pursuing Rotary.
- Report on The Rotary Foundation Josh Mansee

Foundation Team Highlights:

- o Team has grown by 10 members, and 3 new subcommittees
- o #1 in Zone for Paul Harris Society Growth and total Rotary Direct membership
- o 265k of DDF (500K+ total) of funds put out in the world doing good via Grants
- o Sponsorship of a Global Scholar & 2 Peace Fellows
- o Trending well to goals for Annual Fund & Polio
- o 4 New Major Donors and 1 Arch Klumpf inductee
- o 68% of clubs have a Foundation Chair
- Report on Charitable Trust District Governor Edwin Bos

The District 6250 Charitable Trust is a 501(c)(3) not-for-profit entity created to assist smaller Clubs within our District by granting the benefits of a foundation without incurring the additional costs of establishing one. The Trust also provides our District the ability to raise tax-deductible funds in support of disaster relief as well as Rotary initiatives, such as Interact, Youth Exchange, and (of course!) polio eradication.

There are 7 clubs within District 6250 that currently have \$21,000 on deposit with the Trust to use for their Club projects. During the last Rotary year, these clubs fundraised \$13,400 for their projects, using the Charitable Trust to ensure preferential tax treatment for the donations solicited. In addition to club projects, our District, through the Trust, supported disaster relief with nearly \$1,500 donated to RID 3850 in the Philippines for Typhoon Phanfone relief. Amazingly, nearly \$10,800 was raised in ONE DAY at PETS training to support a great non-profit organization of one of the featured speakers. \$3,800 was donated to the End Polio Now fund through sales of "Give Rotary the Finger" apparel. Nearly \$20,000 of funds are on deposit with the Trust endowing the McKinney-Marshall Fund, which annually grants scholarships for youth exchange.

• Report on Election for RI Director Election Committee Representative and confirmation of Bill Hoel, Rotary Club of La Crosse – District Governor Edwin Bos

Must be a PDG and several other criteria such as attending Zone meetings etc.. All our PDG's were asked but only PDG Bill Hoel both stepped forward and was eligible. Under RI Bylaws section 11.020.7.

No ballot shall be required if there is only one nominee in a district. The governor shall declare the nominee as the member of the nominating committee. Bill's name has been submitted to RI to serve on the Nominating Committee for RI Director this fall.

Minutes of Previous Meeting

The minutes of the annual business meeting of June 7, 2019 were not read because they had previously been distributed.

A motion to approve the *minutes from the business meeting* of June 7, 2019 was made by General Consensus. No objections. Approved.

Treasurer's Report

Approval of the 2018 – 2019 Financial Statements – District Treasurer Dick Spencer

District Treasurer Dick Spencer presented the Financial Statements.

Per Rotary procedure the Audit Report was conducted and included in the Annual Meeting Packet. December 18, 2019 the audit committee reviewed the fiscal year end June 30, 2019 and District Governor Bill Hoel's annual expenses.

District Treasurer Dick Spencer, Rotary Club of La Crosse Valley View thanked Darwin Isaacson, Rotary Club of La Crosse Valley View, Scott Haumersen, Rotary Club of Madison, Todd Restel, Rotary Club of LaCrosse and Arien O'Heron, Rotary Club of Caledonia for their work on the District Audit Committee.

The District ended up expenses in the excess of revenues of \$22,904.65 on the fiscal year.

A motion to approve the 2018 – 2019 Financial Statements was made by General Consensus. No objections. Approved.

Approval of 2020-2021 District Budget and District Member Dues

District Treasurer Dick Spencer, District Governor-Elect Bill Pritchard

Budget for \$72,629 loss for the 2020-2021 fiscal year. The finance committee is recommending that we maintain the dues at \$40 per member. The intent is to keep a reserve balance of 55% of the operating balance.

A motion to approve the *2020-2021 District Operating Budget* was made by General Consensus. No objections. Approved.

Question form the floor – the reserve is around \$179,000 for the District. Rotary International has a target reserve of 55% of operating expenses.

Board Member Elections

The District Nominating Committee has nominated two at-large members to the District 6250 Board of Directors for 2020-21. The nominating committee nominates At-Large Member Carol Hermann (Rotary Club of Lodi), and Marie Whisenant (Rotary Club of Southwest Wisconsin-Platteville).

Motion to approve members Carol Hermann (Rotary Club of Lodi), and Marie Whisenant (Rotary Club of Southwest Wisconsin-Platteville) to the *District Board of Directors* was made by General Consensus. No objections. Approved.

Motion to approve Karen Hebert, Rotary Club of Chippewa Valley After Hours, as *District Governor Elect 2020-21* was made by General Consensus. No objections. Approved.
